General Definitions and Scope

These Terms and Conditions govern user participation in brokerage partner promotions offered through the StarryTrader platform, operated by **Advanced Semiconductor IC Design Pte. Ltd. (UEN 202206358H), trading as StarryTrader ("StarryTrader")**.
